Our Admissions Committee reviews the work profile, prior educational qualifications and online selection test score to shortlist the best candidates for this program. In your case, the committee took the decision of enrollment based on your performance in the selection test.

The program begins on**31st March 2020**. However, we will be commencing with the preparatory sessions immediately as soon as you deposit the caution money.

To confirm your acceptance of the offer, please complete the admission formalities as per the following timelines:

- Caution Money of INR 25,000 to be paid within 3 days of receiving the offer letter.
- You will have 15 days to complete the balance payment from the time of your caution money payment. You can pay the balance payment using one of the following options:
 - You can use Netbanking, Credit card or Debit card to complete the balance payment within 15 days from the time of the caution money payment.
 - You can apply for an EMI loan. If you want to apply for an EMI loan, you will have 10 days from the date of the caution money payment to submit the complete application, post which this option will not be available. The processing time for the loan is 2-4 days.

Refund Policy

- 1. You can claim a refund for the course at any time, before the cohort start date by visiting www.upgrad.com and submitting your refund form via the "My Application" section under your profile. Processing fee of Rs. 10,000 will be levied.No refund is permitted once the cohort commences.
- 2. Student has to pay the full fee within 15 days of payment of caution amount or cohort start date, whichever is earlier, otherwise the admission letter will be rescinded.

Further, the fees is non-refundable once the classes commence. Request for refund must be sent via e-mail in the prescribed Refund Request Form. The refund will be processed within 30 working days of commencement of the program after being duly approved by the Academic Committee.
