- To provide guidelines for the redressal of grievances related to harassment of female students, teaching, and non-teaching women staff of the Institution.







4. Survey analysis


A survey of gender equity and sensitization was conducted on campus using an online questionnaire.


ONLY FOR Girl Students

Adequate facilities are available inside the toilet keeping in mind the needs of the girl students. Adequate disposal bins are available in the toilet







Adequate lighting is available inside the campus during the night, including but not limited to, adequate light in corridors, classrooms, common areas, toilets, etc.
